

VILLAGE OF GOLD RIVER

Fees and Charges Amendment Bylaw No. 734.1, 2022

A bylaw to amend the Fees and Charges Bylaw.

**WHEREAS** pursuant to the Community Charter S.B.C. 2003, c. 26, as amended from time to time, and the Local Government Act R.S.B.C. 2015, c 1 as amended from time to time Council may, by bylaw, impose municipal fees in respect of all or part of a service of the municipality, the use of municipal property, the exercise of authority to regulate, prohibit or impose requirements, or in respect of such other matters permitted by and enactment;

**NOW THEREFORE** the Council of the Village of Gold River in open meeting assembled, enacts as follows:

1. That Section 7 and 8 be added to the Village of Gold River Fees and Charges Bylaw No. 734, 2021 as follows:
  7. Penalties for offences against this bylaw are set out in Schedule “A” of the Village of Gold River Bylaw Notice Enforcement Bylaw No. 737, 2022, and may be enforced by Bylaw Notice or Municipal Ticket Information.
  8. Each day an offence continues constitutes a separate offence.
2. That Schedule “G” Business Licence Fees in the Village of Gold River Fees and Charges Bylaw No. 734, 2021, be amended to reduce the Annual Fee for Retail/wholesale cannabis or cannabis products to \$75 effective January 1, 2022.
3. That Schedule “H” Annual Dog Licencing Fees, attached to and forming part of this bylaw, be added to the Village of Gold River Fees and Charges Bylaw No. 734, 2021.

**TITLE**

4. This bylaw may be cited as the “Village of Gold River Fees and Charges Amendment Bylaw No. 734.1, 2022”.
