VILLAGE OF GOLD RIVER

BYLAW NO. 721, 2020

A BYLAW FOR THE ADMINISTRATION OF THE FREEDOM OF INFORMATION AND PROTECTION OF PRIVACY ACT

WHEREAS the Freedom of Information and Protection of Privacy Act, RSCB 1996, Chapter 165, as amended, requires that a municipality designate the Head and set any fees for services.

NOW THEREFORE, Council for the Village of Gold River, in open meeting assembled, enacts as follows;

1. TITLE

This Bylaw may be cited as "Freedom of Information Bylaw No. 721, 2020".

2. DEFINITIONS AND INTERPRETATION

- a. The definitions contained in Part 1 of the Act shall apply to this Bylaw except where the context requires otherwise.
- b. In this Bylaw"

"Act" means the "Freedom of Information and Protection of Privacy Act", RSBC 1996, Chapter 165.

"Commercial Applicant" means a person who makes a request for access to a record to obtain information for use in connection with a trade, business, profession or other venture for profit.

"Coordinator" means the person designated in section 3 b. as the Information and Privacy Coordinator.

"Council" means the Council of the Village of Gold River.

"Head" means the person or group of persons designated as the Head of the Municipality under section 3 a. of this Bylaw.

"Municipality" means the Village of Gold River.

"Request" means a request under section 5 of the Act.

3. Administration

a. The Council hereby designates the Corporate Officer as the Head for the purposes of the Act, and in the absence of the Corporate Officer, the Director of Finance to act as the Head.

- b. The Council hereby designates the Deputy Corporate Officer as the Information and Privacy Coordinator for the purposes of the Act, and in the absence of the Deputy Corporate Officer, the Deputy Finance Officer to act as Information and Privacy Coordinator.
- c. For the purposes of the Act, the Head and Coordinator shall act in their respective capacities for all Boards, Committees, Commissions and Municipal Corporations of the Village.

4. POWERS OF THE COORDINATOR

The Coordinator is hereby authorized to perform any duty and exercise any function that the head is authorized or empowered to perform or exercise under the Act.

5. FEES

The Schedule of Maximum Fees as established by British Columbia Regulation 323/93, as amended from time to time, shall be the maximum fees charged the Village as permitted under the Act.

6. REPEAL

Village of Gold River Freedom of Information Bylaw No. 528, 1994 and its associated amendments are hereby repealed.
