Jack Christensen Centre - FireSmart Renovations

The Village of Gold River invites quotations from qualified vendors to undertake FireSmart Renovations behind the Jack Christensen Centre located at 396 Nimpkish Drive in Gold River, BC.

Quotations clearly marked "Jack Christensen Centre - FireSmart Renovations" will be accepted at the office of the Village of Gold River at 499 Muchalaht Drive, Gold River, BC V0P 1G0, until **2:00 pm Pacific Time on Friday, November 24th**.

All prices must be quoted in Canadian dollars with applicable taxes shown separately. Prices are to remain valid for a minimum period of 120 days from the submission deadline.

The vendor is solely responsible for ensuring that the quotation is received at the Village of Gold River' office before the submission deadline.

The following criteria will be used to select the most advantageous quotation:

- a) Ability to meet the time requirements and stipulations as specified in this RFQ;
- b) Relevant experience and qualifications; and
- c) Lowest price to the Village of Gold River.

RFQ JCC-23 SPECIFICATIONS

The Village of Gold River requires a qualified consultant to undertake the following FireSmart Renovations behind the Jack Christen Centre (Appendix A):

- Remove the existing vegetation and pine trees (not mature) and create a non-combustible zone of crush stone that extends 1.5 meters from the building (approximate dimensions 51' x 260');
- Lay proper weed sheeting underneath the crush to ensure minimal vegetation regrowth;
- Dispose of the vegetation removed from the site; and
- Install 4 concrete footings for an 8' x 20' shipping container (seacan) to be located on (Appendix B).

Interested proponents wishing to undertake a site tour of this building can do so at their convenience as this is an open public space.
