REQUEST FOR QUOTATIONS**

Supply & Delivery of Enclosed Trailer

The Village of Gold River invites quotations from qualified vendors to supply and deliver an enclosed 20' trailer.

Quotations clearly marked "Supply & Delivery of Enclosed Trailer" will be accepted at the office of the Village of Gold River at 499 Muchalaht Drive, Gold River, BC V0P 1G0, until **2:00 pm Pacific Time on Friday, November 24th**.

All prices must be quoted in Canadian dollars with applicable taxes shown separately. Prices are to remain valid for a minimum period of 120 days from the submission deadline.

The vendor is solely responsible for ensuring that the quotation is received at the Village of Gold River's office before the submission deadline.

The following criteria will be used to select the most advantageous quotation:

- a) Ability to meet the time requirements and stipulations as specified in this RFQ;
- b) Lowest price to the Village of Gold River.

RFQ SPU1-23 SPECIFICATIONS

The Village of Gold River requires a qualified consultant to supply and deliver an enclosed trailer that meets the following criteria:

- Delivered to the Oyster River Firehall at 2241 Catherwood Road, Black Creek, BC;
- Contains a 4' x 4' logo of the Gold River Fire Department on each side with the words Structural Protection Unit underneath (Appendix A) written in black;
- 20 feet in length;
- 7 feet in width;
- Roof ventilation;
- Leaf-spring axels;
- Welded safety chains;
- Interior lighting;
- Tandem axel;
- Galvanized roof;
- Ramp at the back (Appendix B); and
- No current storage modifications, such as shelving, existing in the trailer.

The Village is willing to consider modifications to the criteria on a case-by-case basis.

Submissions must include pictures.
